SPECIFIC CONDITIONS :

1. Computer room should be air conditioned and faculty member to teach computer course should be appointed.
2. Staff room should have small cabins and should be provided all necessary with facilities.
3. Machine room should be equipped for B.Pharmacy classes by procuring additional/different equipments/instruments.
4. Lecture room should have proper infrastructure (benches, fans etc.)
5. Balance room should be augmented by 10 more balances.
6. Pharmacology and Pharmaceutical labs. need to be strengthened by procuring deficient equipments.
7. Animal house should be provided in bigger room with all necessary facilities.
8. Drawing hall should be constructed.
9. Library needs to be strengthened by more number of text books and journals.
10. Faculty members in the following subjects should be appointed :
 - i) Anatomy and Physiology
 - ii) Basic Electronics & Computer Education.
